2. Can I send a deposit ticket?

No! Some banks do not include their routing number on their deposit ticket which is the information needed by the Village.

3. What if there is an error on my bill?

Call the Village Hall as soon as you discover the error, but no later than five working days before the bill due date.

4. How long will it take for the automatic payment to take effect?

Upon receipt of the application, you will be enrolled. A notification will be on your utility bill.

5. What day would my bank account be deducted? Your account will be deducted on or within two days after the bill due date indicated on your billing statement.

6. Does the Village offer Credit Card Payments?

Yes, the Village offers E-Pay Credit Card payments available at: http://bannockburn.org; with a nominal fee. Note: Automatic credit card payments will be coming soon.

7. Will the Village sell my information?

No! Your account information will be kept private and secured.

Auto Pay Authorization Agreement Terms and Conditions

The following terms and conditions ("Terms and Conditions") apply to your application for and use of the automatic monthly payment service ("Auto Pay") provided by Village of Bannockburn. The Village of Bannockburn reserves the right to change these Terms and Conditions at any time.

- 1. YOUR RESPONSIBILITIES. You agree to provide (a) true, accurate, current, and complete information when applying for, modifying information of, or using Auto Pay, (b) not to misrepresent your identity, and (c) not to use Auto Pay for any illegal purpose. Your use of Auto Pay constitutes your consent to be bound by the Terms and Conditions stated herein, as may be amended from time to time by the Village of Bannockburn.
- 2. AUTOMATIC PAYMENTS. Automatic payments will be deducted from your bank account on or within two business days after the due date indicated on your monthly billing statement.
- 3. CHANGES. You may request the Village of Bannockburn to add or substitute accounts at any time during your use of Auto Pay pending submission of a new application.
- 4. BANK CHARGES. You agree to pay all applicable bank charges for any automatic payment that is returned unpaid to Village of Bannockburn. You must notify Village of Bannockburn when you change or close the authorized bank account(s).
- 5. DISCLAIMER OF WARRANTIES. You expressly understand and agree that your use of Auto Pay is at your sole risk. The Auto Pay service is provided on an "AS IS" and "AS AVAILABLE" basis. The Village of Bannockburn expressly disclaims all warranties of any kind, express or implied. Village of Bannockburn does not warrant that Auto Pay will meet your requirements or that Auto Pay will be uninterrupted, timely, secure, or error-free. To the extent that any part of this section is not consistent with any other part of these Terms and Conditions, this section will control.
- 6. LIMITATION OF LIABILITY. Village of Bannockburn will reimburse you for wrongful debits made as a result of an error by Village of Bannockburn and actual bank charges incurred as a result of that error. Village of Bannockburn shall not be liable for any other damages of any kind or character, including any direct, indirect, incidental, consequential, special, or punitive damages resulting from (a) any wrongful debit, (b), your use of or inability to use Auto Pay, (c) unauthorized access to or alteration of your transmission or data, or (d) any other matter relating to Auto Pay.
