Dear President Rothing, Police Commissioner Boyle, and Board of Trustees:

On behalf of the members of the Bannockburn Police Department, I am pleased to submit our 2020 Annual Report. This report describes the accomplishments of our police officers including their deterrence and enforcement actions, involvement in Village of Bannockburn events, and services developed to assist our Village residents.

The year 2020 was a year of challenges. While all countries faced the twin threats of the worst pandemic the world has seen in more than a century and sharp economic downturns, the U.S. found itself in a unique position with levels of social unrest. The impact of these disasters was felt by the Village of Bannockburn Police Department and actions were taken to manage through the challenges with grace and courage. The department has responded to the pandemic in various ways such as minimizing the number of officers reporting to work, completing training online from home, implementing safety precautions for officers, maintaining social distancing protocols, sanitizing police vehicles, and adjusting to minimal contact with the public – very unique adjustments for our profession. Following the death of George Floyd, in May, unrest broke out and quickly spread across the country and the world. Widespread property destruction and looting occurred and the threat required the Bannockburn Police department to increase the number of patrols, its interaction with the public, and hours worked.

During this challenging time, the Village Board and the Village residents continued to support their police department and its officers. Realizing the importance of resident safety, the Village Board agreed to increase staff from seven to eight full-time officers to allow scheduling of two officers per shift, continued to support training initiatives, and provided budgeted funds to purchase necessary equipment to help them serve the community.

Training remains a high priority in the department, while most in-person training was cancelled due to the pandemic, the department continued its outdoor firearms training and increased its online training to stay current with laws and proper police procedures.

The department remains committed to implementing programs and ideas which will make us more effective, efficient, and accessible to the residents we serve. Although we are small, our size does not limit our vision to be the best we can be.

Thank you, President Rothing, Police Commissioner Boyle, Trustees, and residents of Bannockburn, for your continued support. We couldn't do it without you.

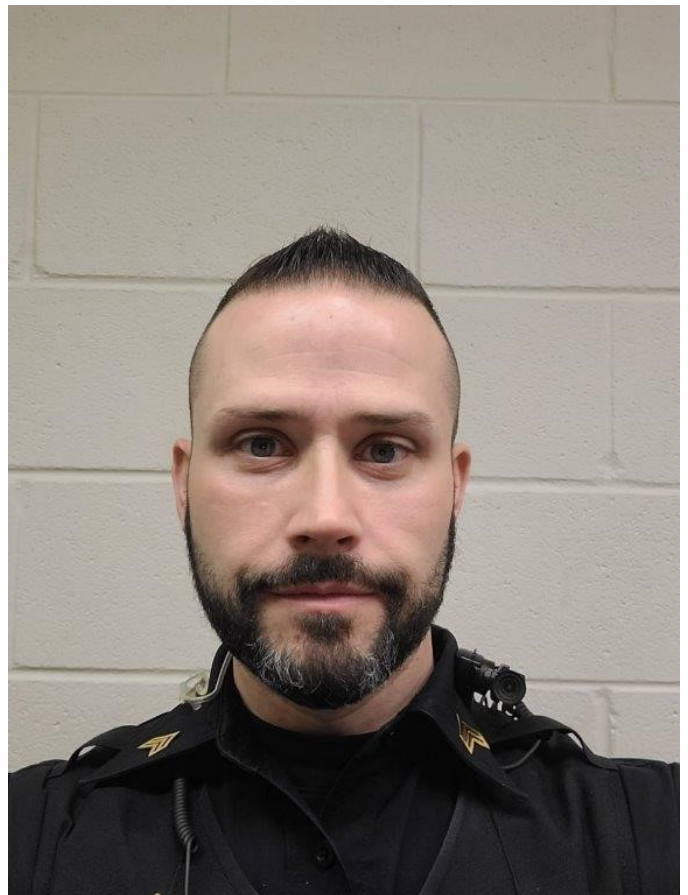

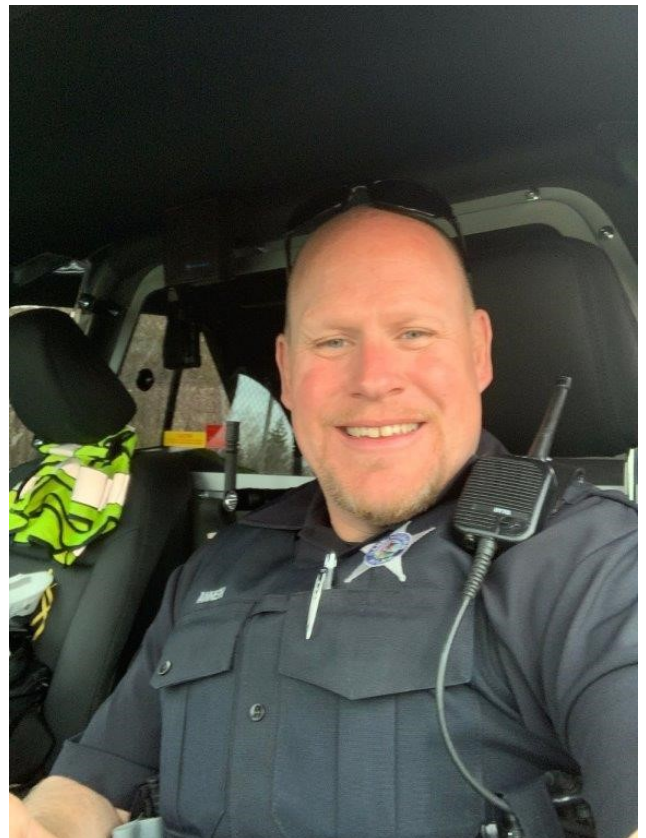

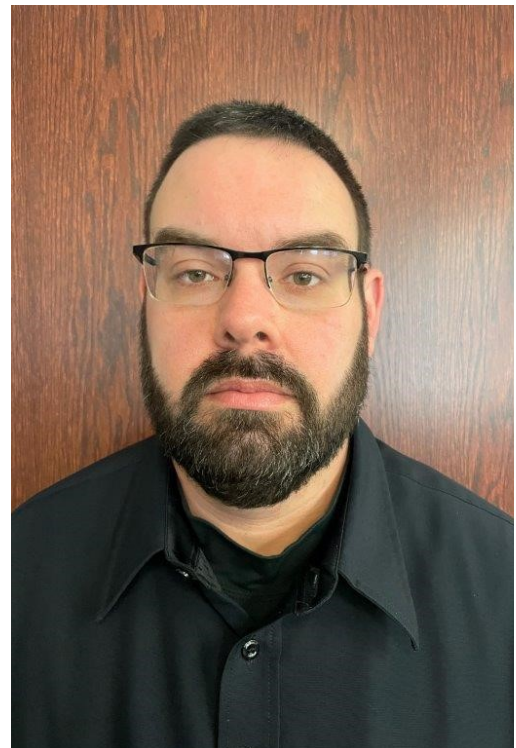

Lieutenant George A. Roberts III's Retirement

On Tuesday, February 11, 2020, Lieutenant George Roberts retired from the Bannockburn Police Department after serving for 14 years. He was hired as an Officer in 2006, promoted to Sergeant in 2016, and was promoted to Lieutenant in 2017. George dedicated a total of 43 years to law enforcement. George served the Wauconda Police Department from 1977 through 2005. He was Walter Trillhaase's Field Training Officer in 1987 when he was hired by the Wauconda Police Department.

On April 4, 2010, George was on patrol in Bannockburn Green. He observed a white pick up truck exiting the rear drive. Due to recent thefts in the area he became suspicious and followed the truck into the Shell Gas Station parking lot. His years of experience and interview skills paid off BIG! The two men had over 20 pounds of packaged marijuana in the truck. The suspects were arrested and charged with Felony Possession and Delivery and Trafficking of Cannabis.

On April 31, 2010 George was on patrol in Bannockburn Green. He saw a man squatting down next to a downspout at the front of the building. He noticed a pry bar and became suspicious. His instincts paid off and he realized the suspect was stealing the copper downspouts. He also cleared a theft case where the same suspect stole the downspouts from the Panera Bread on March 30th.

On August 18, 2006, George was on patrol in Bannockburn Green. He observed a man exiting Dominick's carrying three packages of meat that were not in a shopping bag. He interviewed the man and asked for a receipt. The man said he did not have one and could not prove he purchased the meat. He was placed under arrest and a subsequent search of his car revealed he also had cannabis and paraphernalia.

George Roberts has received several awards for perfect attendance throughout the years and he has also been acknowledged for his perseverance in parking enforcement, focusing mostly on Handicapped Parking Violators.

Thank you, George, for your 14 years of dedicated service to the Village of Bannockburn.





Officer Mark Chandler's Retirement

On Monday, January 24, 2020, Officer Mark Chandler retired from the Bannockburn Police Department.

In 1980, Officer Chandler was hired by the Vernon Hills Police Department. In 2000, he was promoted to Corporal, and in 2002, he was promoted to Sergeant. And finally, in 2006, he was promoted to Commander. In 2010, Officer Chandler retired from the Vernon Hills Police Department, and was hired by the Bannockburn Police Department as a part-time officer. In 2012, he was hired by the Lake County Sheriff's Office as a Court Security Officer.

Officer Mark Chandler is leaving the Bannockburn Police Department after more than 40 years in law enforcement. He will continue to work for the Lake County Sheriff's Office. On Monday, March 9, 2020, Officer Chandler was presented with a Retirement Award to thank him for his service with the Bannockburn Police Department.

Officer Patricia McConnell's Retirement

On Monday, March 9, 2020, Officer Patty McConnell was presented with a Retirement Award for her service with the Bannockburn Police Department.

In 1978, Officer McConnell was hired by the Winnetka Police Department,. She was later promoted to Sergeant, before she retired in 2005 after 27 years of service in Winnetka. In 2005, she was hired by the Illinois Attorney General's Office as the Director of Investigations. In the same year, she was hired by the Bannockburn Police Department as a part-time officer. Officer McConnell was the designated Northern Illinois Police Alarm System's Hostage Negotiator. She responded to mutual aid call-outs where there was a need or potentially a need for a negotiator for a hostage situation or a barricaded subject. Her team's goal was to de-escalate, negotiate, and peacefully resolve critical situations.

Officer Patty McConnell leaves us with more than 40 years of service in the law enforcement community. She will continue to add years, as her next stop is to the Kildeer Police Department where she will continue her work with NIPAS.

Assist to the Highland Park Police Department

On Monday, February 3, 2020, Officer Dave Lemmer and K9 Odin assisted the Highland Park Police Department with tracking a missing 15 year-old, autistic girl. She had gotten into an argument with her mother and left the residence in her pajamas, robe, and no shoes in 38-degree weather. Officers searched for an hour. When Officer Lemmer and Odin arrived, they located the girl, who was cold, but otherwise in good condition.

Assist to the Northbrook Police Department

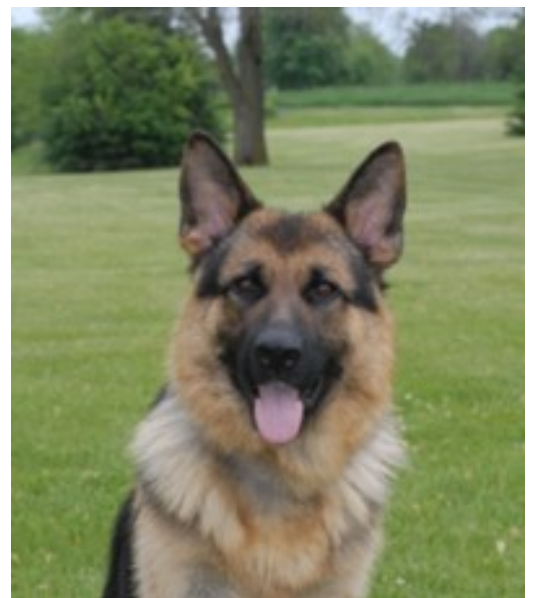
On Wednesday, February 26, 2020, Officer Dave Lemmer and K9 Odin assisted the Northbrook Police Department with the sniff of a vehicle on a traffic stop. 2.25 grams of heroin/fentanyl, 4.75 grams of methamphetamine, 2 glass meth pipes, 4-6 grams of cannabis, three THC vape cartridges with a vape pen, a scale, and numerous plastic bags containing residue were located in the suspect's vehicle.





Officer Dave Lemmer and K9 Odin's Retirement

On Tuesday, June 30, 2020, Officer Dave Lemmer and K9 Odin retired from the Bannockburn Police Department. Officer Lemmer graduated from the Police Training Institute as a certified Police Officer in 1978 and graduated from Western Illinois University with a Bachelor's Degree in Social Justice in 1984. After working for both the Peru and Paw Paw Police Departments, Officer Lemmer began his career with the Deerfield Police Department in 1984 and retired in 2005. On February 28, 2005, Officer Lemmer began his employment with the Bannockburn Police Department as a part-time officer. On May 9, 2005, he was sworn in as a full-time officer for the Bannockburn Police Department. Officer Lemmer was teamed up with K9 Dex from 2010 until 2013, when Dex suddenly passed away. Officer Lemmer then partnered with K9 Odin until they retired together on June 30, 2020. Officer Lemmer and his K9 partner's shoes can never be filled here. They will both be greatly missed.







SIGNIFICANT CASES





Retail Theft at Walgreen's

On Saturday, January 4, 2020, Lieutenant Michael Volling was dispatched to the Walgreen's store in Bannockburn Green Retail Center where a retail theft was reported. A description of the offenders and their vehicle was provided over the police radio. Deerfield Police Officers stopped the vehicle in front of their police department for speeding. The occupants fit the description of the retail theft suspects and they had a large quantity of Dove products in their vehicle. Lieutenant Volling made contact with Walgreen's employees and learned approximately \$700.00 worth of merchandise was stolen. It was subsequently recovered from this stop and the vehicle occupants were charged with retail theft and released on bond.

Possession of a Controlled Substance at Bannockburn Green Retail Center

On Thursday, February 13, 2020, at approximately 10:20AM Officer William Annen was asked to assist the Libertyville PD in locating a stolen "Bobcat" skid steer at the Bannockburn Green Retail Center. He arrived a few minutes prior to the Libertyville PD Detectives. He located a "Bobcat" and parked next to it. While waiting for Libertyville Detectives, a male exited a white car parked next to the "Bobcat" and a conversation ensued. Officer Annen became suspicious of the suspect, got out of his squad car and the suspect began to walk away. Officer Annen ordered the suspect to remain for his investigation and he refused. Officer Annen then placed his hands on the suspect, and the suspect attempted to pull away. They both ended up on the ground, at which time Libertyville PD Detectives arrived and assisted Officer Annen with handcuffing the suspect. The suspect stated that the reason he wanted to walk away was due to the cocaine he had in his pocket. He was transported to the Deerfield PD where he was processed, charged with Possession of Cocaine and Resisting a Peace Officer. He was then transported to the Lake County Jail. Libertyville Detectives determined the "Bobcat" located, was in fact the one reported stolen from Libertyville. It was recovered and returned to the owner.



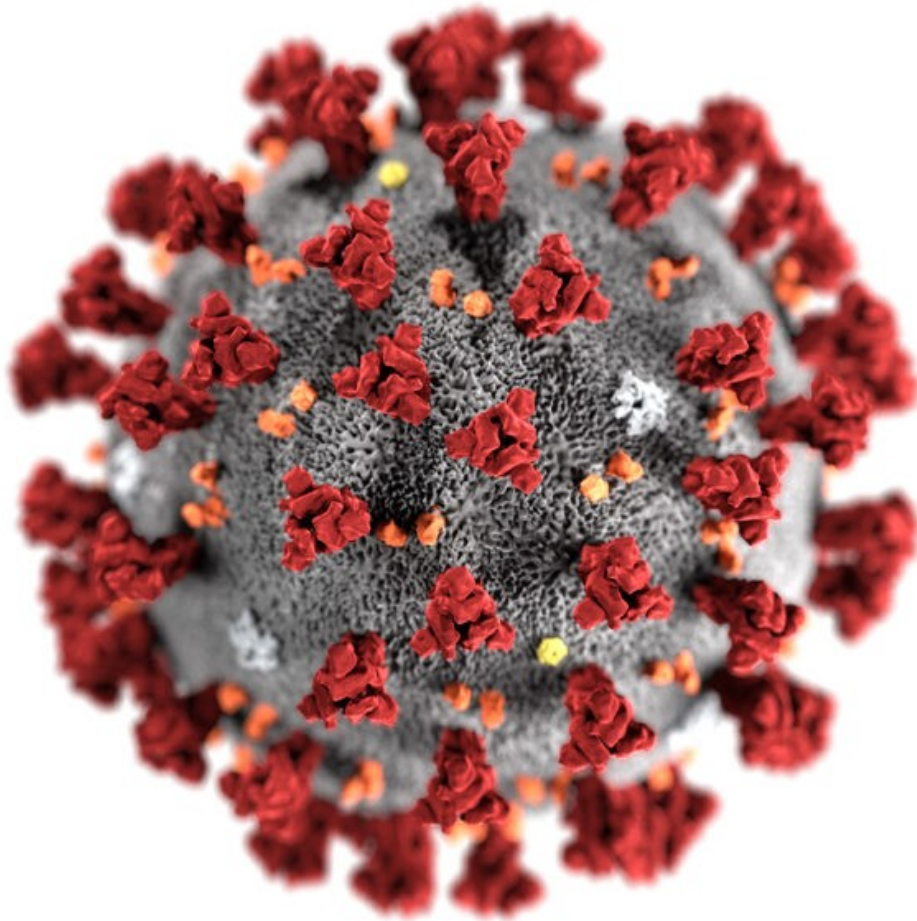

Once a week, Officer Ogden would sign-in to the Zoom platform and conduct the lessons. This method went better than expected and the students had a good time.

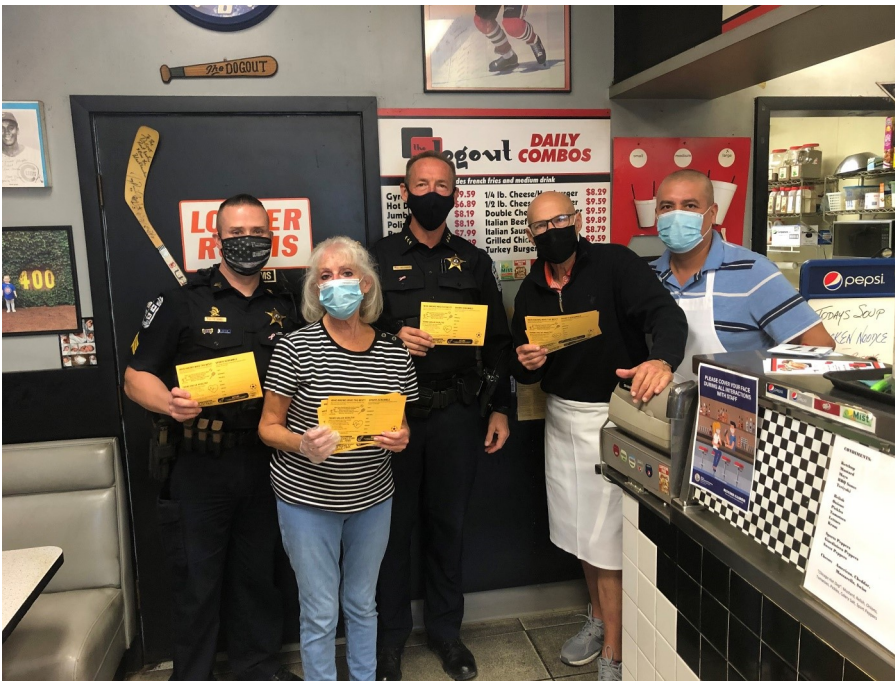




Community – The Anti-Drug (CTAD)

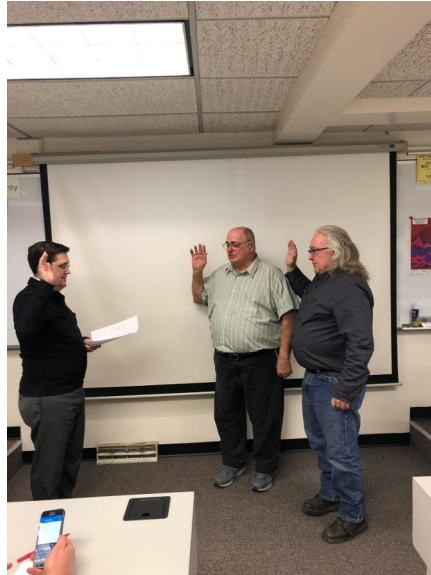

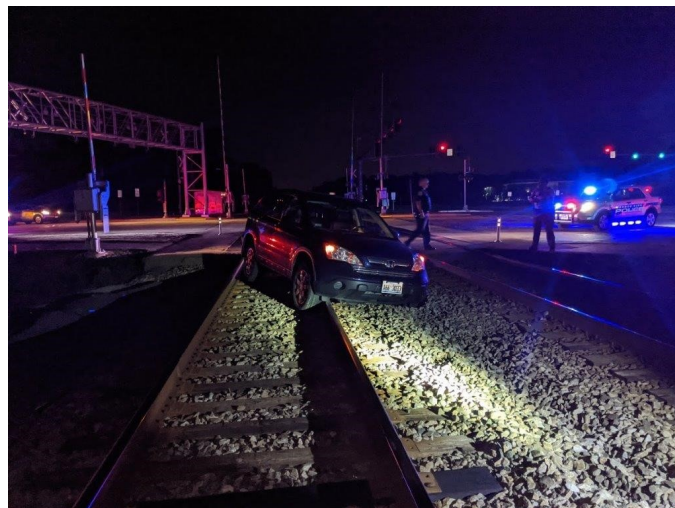
Emergency Management Coordinating Council of Lake County

Police Commissioner Boyle was sworn in as the Vice President. The EMCCLC meets once a month to discuss emergency management strategies and Lake County events. These meetings are attended by various law enforcement and other governmental agencies from Lake County.



Route 22 Traffic Safety Campaign

On Sunday, February 2, 2020, the Bannockburn Police Department, along with police departments from Buffalo Grove, Highland Park, Lake Zurich, and the Lake County Sheriff's Office took part in a special traffic safety campaign in conjunction with this year's Super Bowl weekend. The Crime Index is used to indicate the amount and extent of Violent Crimes and Property Crimes, in a given jurisdiction, as defined by the International Association of Chiefs of Police Committee on Uniform Crime Reports (UCR). 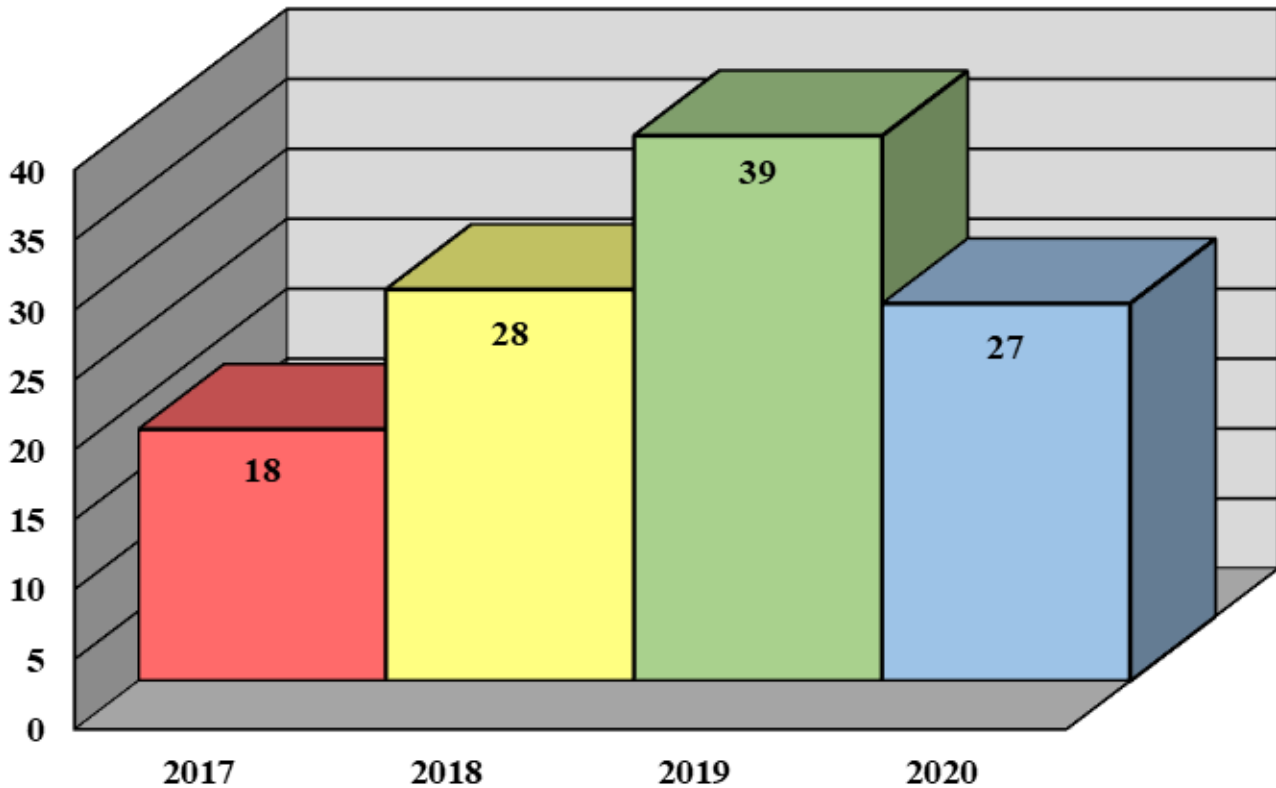
The Crime Index is the total number of indexed offenses occurring within a given jurisdiction during a specified period of time. In 2020, Bannockburn had a crime index of 27.

Four Year Comparison

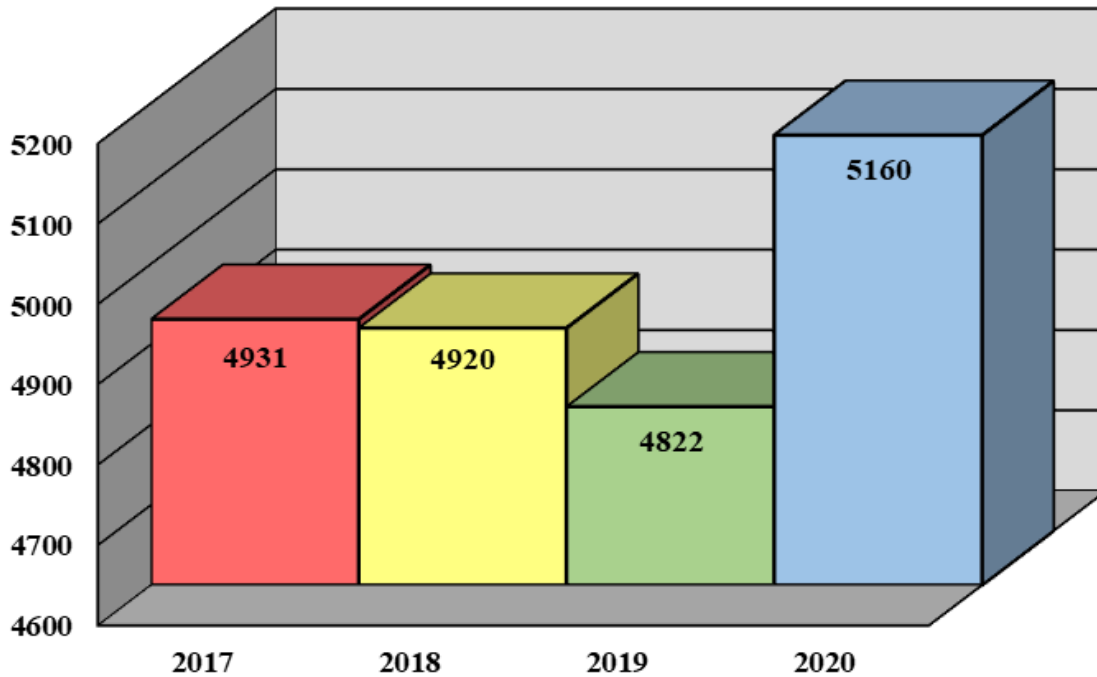

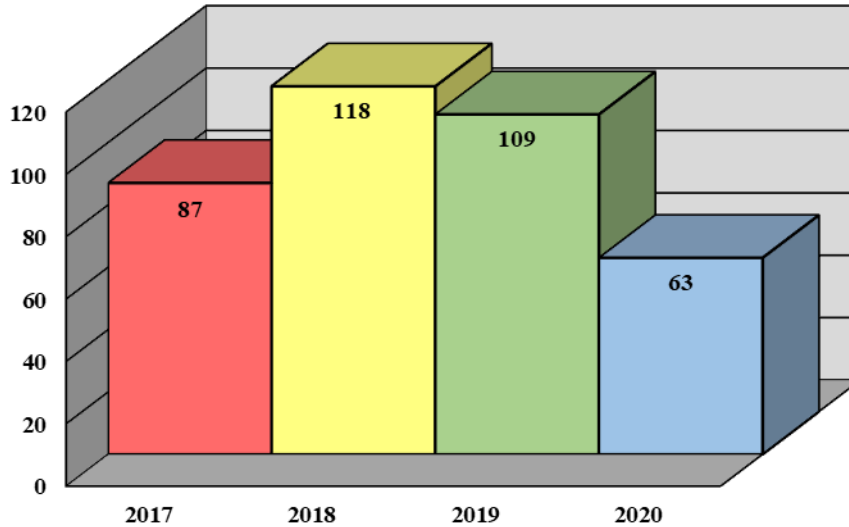

Four Year Comparison



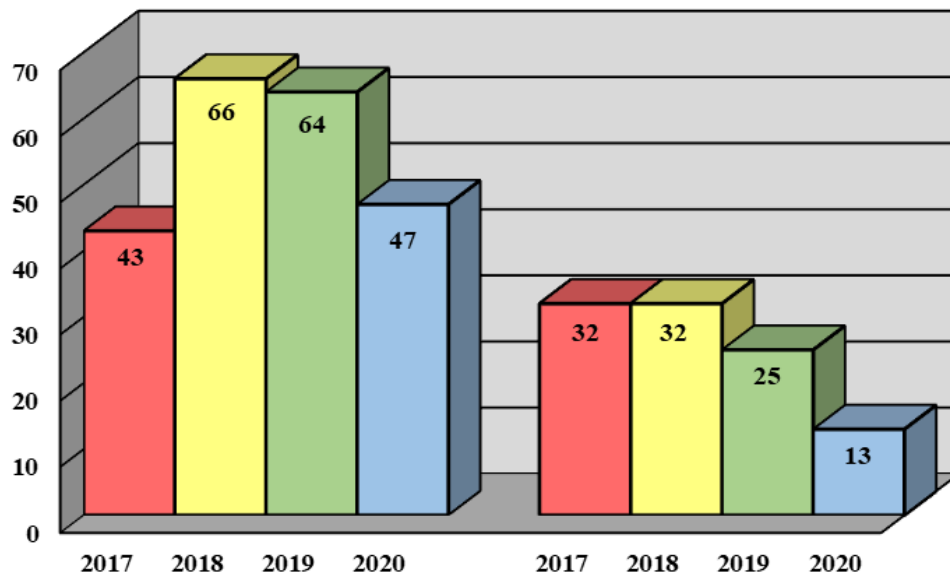

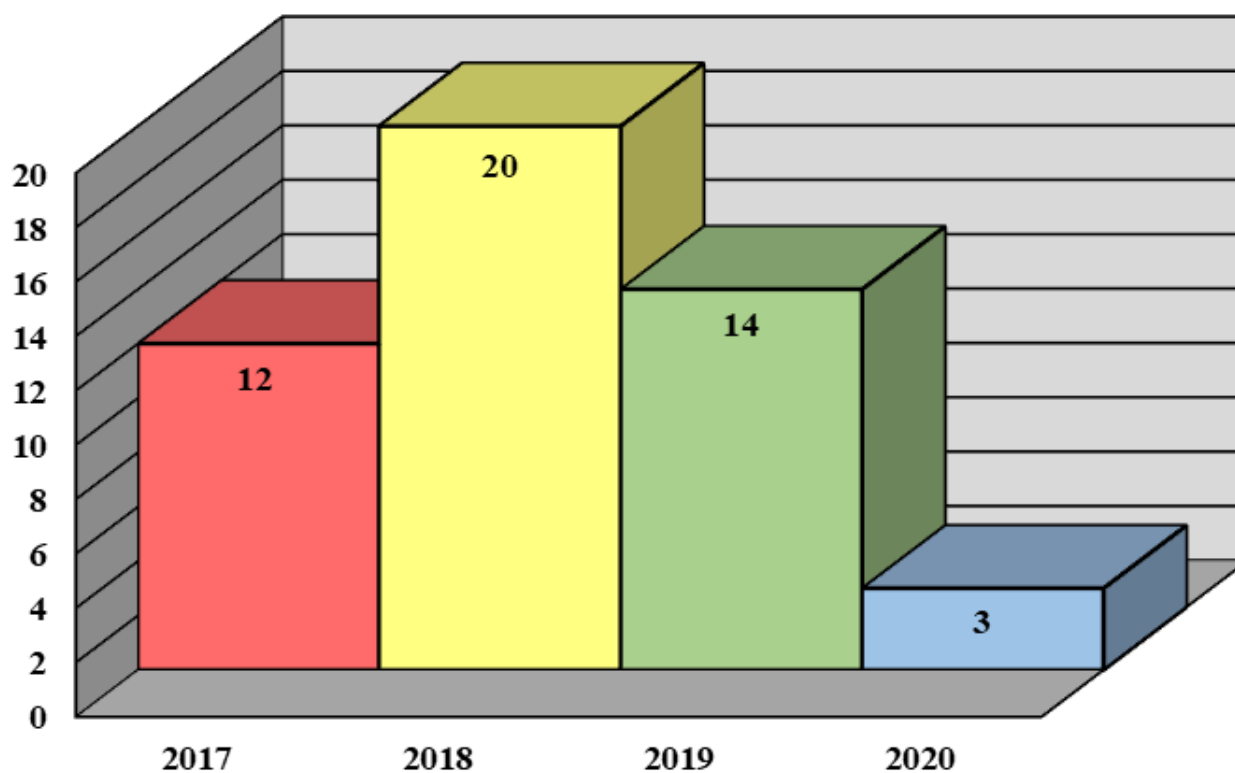

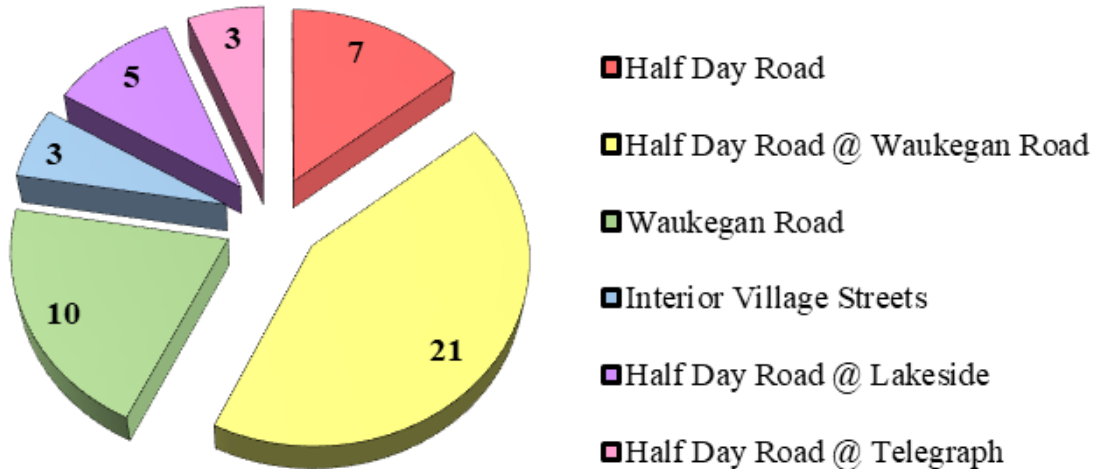

Traffic Accident Locations

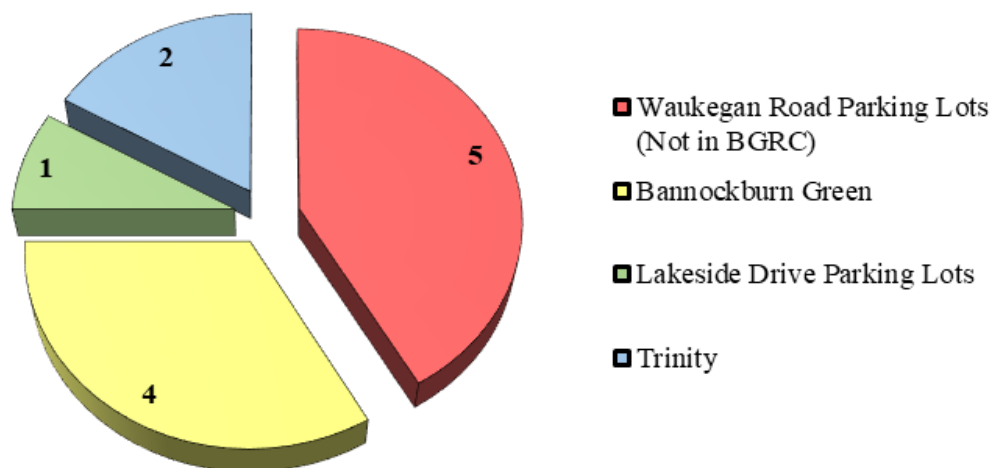

Half Day Road (IL Route 22) at Waukegan Road (IL Route 43) was the number one location for traffic crashes.

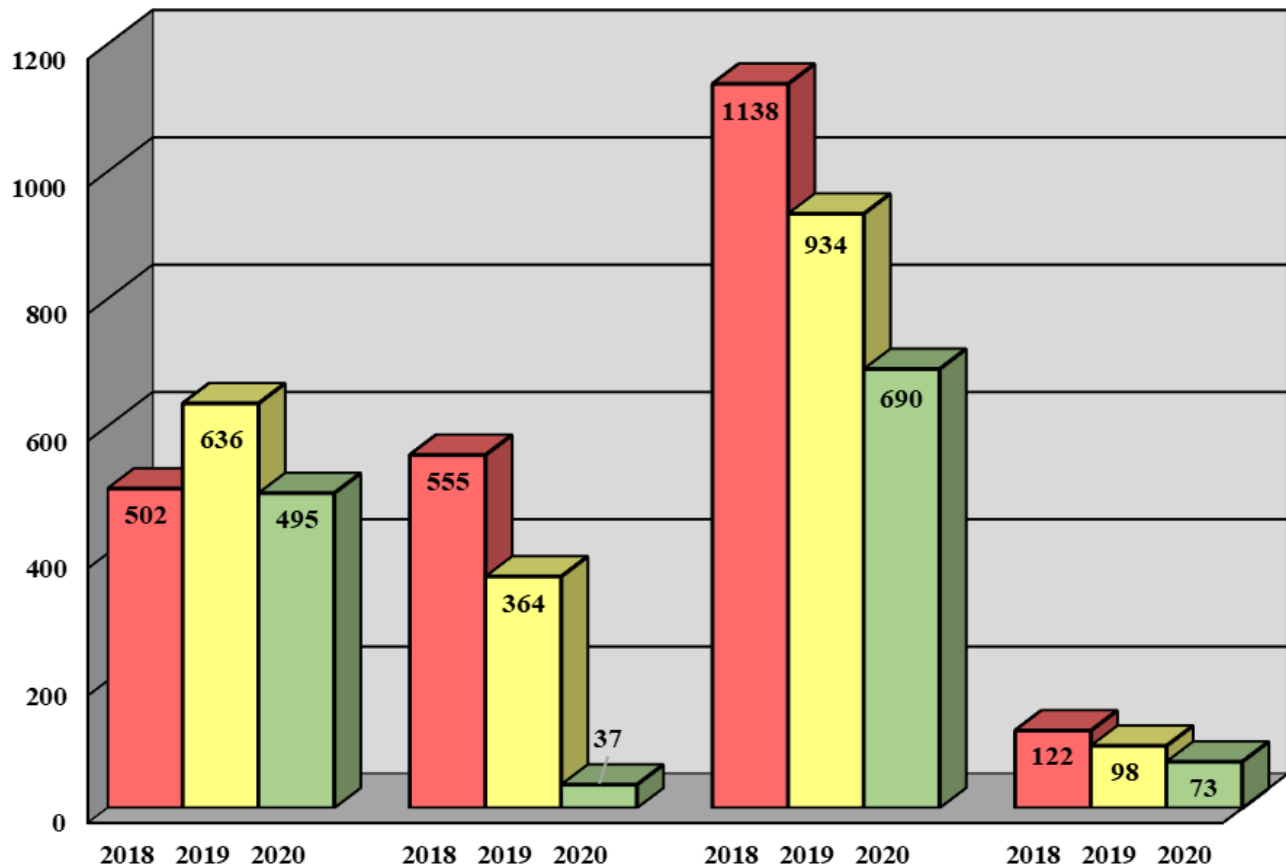
Private Property Traffic Accident Locations

Enforcement Activity



In 2011, the Department implemented a Compliance ticket as a way to issue a citation for minor violations that would often times be dismissed by a judge in court or, because of the high fine associated with the charge, an officer would not issue a ticket. Compliance tickets cover minor infractions such as tinted driver's window, seat belts, one headlight, cell phone use, etc.

The officers issue written warnings for minor infractions such as failure to use a turn signal or for other less serious violations. Since our system changed in 2011, the officers are able to use this third option when stopping a vehicle for a traffic violation in the Village of Bannockburn.



Traffic Stop Data Collection

The Bannockburn Police Department expressly prohibits racial profiling and other biased -based policing.

Since 2004, all Law Enforcement Agencies in Illinois are mandated to keep statistical data on every vehicle that is stopped for a traffic violation. The Illinois Department of Transportation is responsible for collecting and compiling the data and results can be found on their website www.dot.il.gov. Regardless of the outcome (verbal warning, written warning or traffic ticket), a “Traffic Stop Data Sheet” is required to be completed. The state mandated program resulted in extra time officers spent completing a traffic stop and additional time by records personnel to input the data into a special computer program.

An important word to understand when looking at traffic stop data is “benchmark.” A benchmark is terminology used by the Illinois Department of Transportation and Northwestern University to describe the acceptable level of minorities being stopped by a community. In the Village of Bannockburn, a 30.58% benchmark was established by Lake County.

At the time of publication of this report, the traffic stop data was not made available by the State of Illinois. When the data is made available, it can be found on the Illinois Department of Transportation’s website.

Multi-Jurisdictional Task Forces

Both large and small police departments pull resources and manpower together in an effort to provide their citizens with the best service possible. This cooperation allows for help, when needed, that would otherwise not be affordable by a single agency. The Bannockburn Police Department belongs to, and participates in, the following task forces:

Major Crash Assistance Team (MCAT)

MCAT was established by an Inter-Governmental Agreement in July, 2004. The Agreement reads in part: “In recognition of the fact that the efficient investigation of serious traffic crashes is enhanced when agencies have access to the resources and support of other agencies. Further, it is recognized that a primary goal in the investigation of serious traffic crashes is to establish an accurate record of the factors and conditions leading up to the traffic crash.” There are 29 contributing agencies and 6 non-contributing agencies involved in MCAT. **Northern Illinois Police Alarm System (NIPAS)**

NIPAS was established by an Inter-Governmental Service Agreement in 1983. The specific intent of this agreement is to permit the police departments of each community to more fully safeguard the lives, persons, and property of all citizens. The NIPAS Car Plan and Emergency Services Team (EST) is the largest multiagency SWAT Team in the Country. The team consists of more than 100 police officers that can handle any tactical situation or high-risk incident. Officers Patricia McConnell (Retired) and Jeff Devroy, NIPAS Hostage Negotiators, assisted the following Northern Illinois Police Departments with the following cases.

Illinois Law Enforcement Alarm System (ILEAS)

ILEAS was established by an Inter-Governmental Agreement in January of 2003. ILEAS is a product of the Illinois Terrorism Task Force of the Illinois Association of Chiefs of Police and is intended to provide a mutual aid system for all law enforcement agencies operating within Illinois. ILEAS is designed to provide law enforcement assistance to communities during any emergency condition and is not limited to acts of terrorism. ILEAS was modeled after NIPAS, except that ILEAS applies to all Illinois Law Enforcement Agencies (county, state, federal, university, and railroad). NIPAS is limited to local municipal law enforcement agencies.



Lake County Metropolitan Enforcement Group (LCMEG)

The Illinois Intergovernmental Drug Laws Enforcement Act authorizes the establishment of Metropolitan Enforcement Groups to promote cooperation and increase efficiency in the enforcement of drug laws among units of local government. LCMEG helps to keep drugs out of the Village of Bannockburn. The group also makes the following services available to member agencies:

- Drug training
- Drug presentations
- Free drug testing kits for parents
- Equipment (undercover vehicles)
- Drug arrest assistance





Mobile Field Force

The Mobile Field Force is designed to provide rapid, organized and disciplined response to civil disorder, crowd control or other situations. Mobile Field Forces are formally structured teams based on a platoon of law enforcement officers from multiple agencies with an assigned leader. Tactics used are based on small squad tactics developed by the Office of Domestic Preparedness as well as the more traditional Mobile Field Force and general police patrol tactics.

Northeastern Illinois Regional Crime Laboratory (NIRCL)

Membership with the NIRCL was established in May of 1987 by an Inter-Governmental Agreement. The agreement was updated in 2007 and the crime lab moved from Highland Park to Vernon Hills. The crime lab performs numerous services for the Bannockburn Police Department:

- Process fingerprints
- Process DUI kits
- Chemistry tests to establish drug identification
- Destroy firearms and drugs
- Handwriting analysis and comparison
- Assist at crime scenes

East Shore Radio Network (ESRN)

The ESRN was established by an Inter-Governmental Service Agreement in September of 1971. Members of the network include Deerfield, Highland Park, Lake Forest, Riverwoods, Highwood, and Lake Bluff. These communities shared the same police radio frequency. The governing board consisted of the Chief of Police from each member department. The network provided purchasing efficiency for radio, telephone, and computer equipment.

The Deerfield Consolidated Dispatch Center

The East Shore Radio Network is in the process of being dissolved. The Deerfield Consolidated Dispatch Center is located in the Deerfield Police Department and its members include the Deerfield Police Department, the Bannockburn Police Department, the Riverwoods Police Department, and its newest member, the Lincolnshire Police Department. All of the listed agencies share the same radio frequency and assist each other when needed for emergencies or calls for service. It is a very excellent team of agencies working together to serve their communities.
