**NOTICE OF PUBLIC HEARING FOR CONSIDERATION OF ZONING CODE
TEXT AMENDMENTS, GRANT OR AMENDMENT OF SPECIAL USE
PERMITS, VARIATIONS, AND/OR OTHER ZONING RELIEF PERTAINING
TO VEHICLE RENTAL AND OUTDOOR VEHICLE STORAGE USES
(Bannockburn Green Retail Center)**

PUBLIC NOTICE IS HEREBY GIVEN that on March 6, 2023 at 7:00 p.m., a public hearing will be held by the Plan Commission and Zoning Board of Appeals (“**PCZBA**”) of the Village of Bannockburn, Lake County, Illinois, at the Bannockburn Village Hall, 2275 Telegraph Road, Bannockburn, IL 60015, for the purpose of hearing and considering testimony with respect to proposed Zoning Code text amendments, amendments to existing special use permits, grant of new special use permits, variations, and any other zoning relief necessary in connection with a proposal to allow two (2) additional small van and small truck rentals, including outdoor and overnight storage of such rental vehicles in an off-street parking lot, in connection with existing retail business activities at the property commonly known as the Bannockburn Green Retail Center and legally described as follows:

Lots 1 through 6, inclusive, in the Bannockburn Green Subdivision, being a subdivision in the South Half of the Southwest Quarter of Section 17, Township 43 North, Range 12, East of the Third Principal Meridian, in Lake County, Illinois.

Commonly known as 2501 Waukegan Road, 2587 Waukegan Road, and 2595 Waukegan Road, Bannockburn, Illinois.

All persons in attendance at the hearing shall have an opportunity to be heard regarding the requested zoning relief. Any person who also wishes to appear as an “interested party” with the right to cross-examine others at the hearing must file an appearance form with the Village of Bannockburn no later than three days prior to the public hearing. Appearance forms are available at the Bannockburn Village Hall, 2275 Telegraph Road, Bannockburn, Illinois.

In the event that public health protocols relating to the COVID-19 pandemic change in a manner that limits or precludes in-person attendance at the public hearing, or requires that public health related precautions be observed for hearing attendees (such as, but not limited to, use of face coverings or social distancing), then additional information regarding meeting attendance protocols will be set forth on the meeting agenda. The meeting agenda, and any other written materials relating to the public hearing, will be posted on the Village of Bannockburn website [<https://bannockburn.org/>] at least 48 hours prior to the hearing.

The above information will be available for inspection at the Bannockburn Village Hall, 2275 Telegraph Road, Bannockburn, Illinois OR the proposed plans can be found on the Village's website (Bannockburn.org) or by scanning the "QR code" on this page (scan me).

The public hearing may be adjourned to another date by the Plan Commission and Zoning Board of Appeals of the Village without further notice other than a notice entered upon the minutes of said meeting fixing the time and place of its adjournment and reconvening.
