On September 13, 2021, the Bannockburn Police Department was presented with the Illinois Law Enforcement Accreditation Program (ILEAP) Award. During the Village Board Meeting, Downers Grove Chief of Police Shanon Gillette, awarded Bannockburn Police Chief Walter R. plaque symbolizing the department's Trillhaase with the ILEAP accreditation status. The accreditation process is a voluntary program which adopts the best practices and policies in policing. The most rigorous component of the process is the independent critique, examination and inspection by outside police professionals. These trained professionals audit, inspect and test the agency's compliance for adherence to 67 professional standards. At the conclusion of the on-site inspection, a report is drafted and forwarded to the ILEAP Council for consideration. We are proud to hold our officers, supervisors and the entire Police Department to the highest standards set by the Illinois Association of Chiefs of Police. We believe the citizens of Bannockburn deserve the best police department possible. This award is an indication of our commitment to excellence.



Accreditation is a journey not a destination. Sergeant Bill Annen continues the journey of collecting documents showing proof of meeting standards and ensuring that we are following policies and procedures. The next evaluation for reaccreditation is set for 2025.

K-9 DEX MEMORIAL AWARD

2023 RECIPIENT: EDWARD PANKO



Ed Panko was awarded the 2023 K-9 Dex Award, an annual award given by the Bannockburn Police Department to recognize one officer or civilian employee for outstanding police service. K-9 Dex served with his handler, Officer Dave Lemmer. from October 25. 2010 November 21, 2013. K-9 Dex was Officer Lemmer's loyal partner, until he passed away unexpectedly, while he was on duty. To honor K-9 Dex, the Department recognizes one employee for outstanding service. This recognition may be one outstanding act by a department member or continuous outstanding performance. Ed is the recipient of this award for his years of consistent dedication to the Bannockburn Police Department. Ed served as a part-time officer before transitioning to a full-time role. Ed has a work ethic second to none.

Residential Burglary

On January 12, 2023, at approximately 6:20PM, unknown offenders entered the rear yard of 10 Broadley's Court. They broke through a window and entered the home. A motion sensor alarm was triggered and scared away the offenders. They did not have a chance to steal anything. It appears that the offenders are from the same group that have struck Bannockburn and many other communities. It was believed the suspects fled to South America, where the group originated. Evidence was collected and sent to the crime lab for analysis.

Reckless Driving

On January 5, 2023, at approximately 2:45AM, Officer Fuerst was dispatched to a vehicle crash on Half Day Rd. Further investigation revealed that the offender was suicidal and purposely drove eastbound in the westbound lanes to intentionally drive head-on with an oncoming car. The other driver was alert and veered off the road at the last moment, avoiding the head-on collision but was still struck by the offender. Tyanna D. Davis of Chicago, was charged with Reckless Driving, Driving While Suspended, Improper Lane Usage, Driving too Fast for Conditions and Operating an Uninsured Motor Vehicle. She was transported to the hospital for a mental health evaluation .The other driver was treated at the scene.

Residential Burglary

On March 3, 2023, the resident of 2360 Telegraph Road went to his home upon receiving information that his utility use had spiked even though he had not been home for several weeks. Upon his arrival he found a broken window on his front door and someone had gained access to his home. The home was in disarray due to his pending move, but many of the dresser drawers had been dumped and other items were disturbed. Nothing appeared to be taken at the time of the report and believes some costume jewelry may have been stolen.

<u>Battery</u>

On April 20, 2023, at approximately 4:22PM, Sergeant Sears and Officer Weshinskey were dispatched to the Police Department in response to a report of a battery. Pinestone Landscaping employee Song (Sam) Suk reported that he and his crew were working in the area of Wilmot and Duffy. Sam pulled his truck into a local resident's driveway because he was yelling at the crew. The resident made several racial comments and then punched Sam in the throat. After interviewing all involved parties, the offender was ticketed for Battery and given a court date.

Warrant Arrest

On August 30, 2023 at 5:21PM Officer Fuerst received an ALPR hit on a vehicle that had a suspended registration for no insurance. He verified the hit and stopped the vehicle. The driver, Lorenzo Estrada admitted he did not have insurance. Upon running a records check, Officer Fuerst learned there was a valid warrant for Domestic Battery. Lorenzo was arrested and transported to the Deerfield Police Department for processing. During the processing, Officer Fuerst located a white powdery substance in a dollar bill in his wallet. The substance was sent to the Crime Lab for analysis for possible additional charges. Lorenzo was transported to the Lake County Sheriff's Office and turned over to them.

<u>Fraud</u>

On October 23, 2023 at 7:28PM Officers Annen and Panko were dispatched to Walgreens regarding a suspicious vehicle. Upon arrival, they located the suspect vehicle. Further investigation revealed that four suspects were in possession of and using fake \$100 bills to purchase gift cards. One suspect fled while officers were arresting the other three. Felony charges were approved for all three arrestees. They were transported to the Deerfield Police Department, processed and detained until their first appearance hearing in Waukegan. 12 counterfeit \$100.00 bills and seven assorted gift cards were seized and logged into evidence.

Possession of a Controlled Substance

On August 30, 2023 at 9:52AM Sergeant Sears received an ALPR hit on a vehicle that had suspended registration for no insurance. He verified the hit and stopped the vehicle near North Ave. The driver, Kyle Anthony Viti was very nervous and could not provide valid insurance and his driver's license was suspended for a previous DUI. When he was taken out of the car to be arrested, he admitted that he had cocaine in his car. Viti was placed under arrest and the search of his vehicle resulted in finding a clear baggie containing a white powder, a glass tube with brown residue and three empty baggies with white powdery residue. All of the evidence was collected and will be sent to the Crime Lab for testing. Viti was transported to the Deerfield Police Department where he was processed and released pending drug charges if approved by the State's Attorney's Office.

Burglary from Motor Vehicle

On December 18, 2023 at 1:02PM in the parking lot of the College Park Athletic Club, an unknown offender smashed the window of a Land Rover Discovery and stole a designer purse, wallet and its contents. The business's surveillance cameras were offline at the time of the offense. While investigating the burglary, Officer Panko received a phone call from a Wilmette Police Detective. He arrested a suspect for committing car burglaries. The suspect was identified as Chayim Avshalom of Hanover Park. Avshalom was in possession of the burglary victim's stolen property. The property was returned to the victim. Criminal charges are being filed by the Wilmette Police Department and the Cook County State's Attorney's Office.

Driving Under the Influence

In 2023, the Bannockburn Police Department made 11 DUI arrests. The Department continues to pursue detecting and arresting drunk drivers to ensure safer roads for citizens traveling through the Village. Sergeant Dennis Sears was awarded with the 2023 MADD Hero award for his continued efforts to enforce DUI laws during the 2022 calendar year.

Mothers Against Drunk Driving (MADD) believes in the importance of acknowledging the hard work that Law Enforcement Officers do across the country in preventing crashes by patrolling and taking impaired drivers off the roads. Every year, MADD Illinois holds a Law Enforcement Recognition banquet to recognize the men and women who have led the fight against drunk/drugged driving and underage drinking within their communities during the prior year.

Bannockburn School and Community Involvement

Did you know the Village of Bannockburn Police Department and Save A Star Drug Awareness Foundation have established a drug disposal and collection program? This program aims to collect and safely dispose of unwanted and unused medications; thus, keeping them out of the hands of individuals who might otherwise become victims of prescription drug abuse. The Save A Star Drug Awareness Foundation was founded in Highland Park by the Katz family following the death of 25-year-old Daniel Katz from an overdose of prescription drug medication in 2007. The Foundation was created to educate the public about the dangers and consequences of prescription drug abuse and addiction, and to

provide tangible methods to remove unwanted and unused medications from America's homes.





Community - The Anti-Drug (CTAD) is a community organization comprised of parents, local, school officials, clergy and healthcare providers. The mission of this coalition is to reduce the use of alcohol, marijuana and other drugs among youth in Bannockburn, Deerfield, Highland Park, Highwood and Riverwoods. The Bannockburn Police Department provided several Bannockburn restaurants with flyers from CTAD to include in their take-out meals. These flyers had activities for families to do together while staying at home and enjoying their meals. Police Commissioner James Boyle and Chief Trillhaase are active with this organization.


The Uniform Crime Reporting (UCR) Program

The Crime Index is used to indicate the amount and extent of Violent Crimes and Property Crimes, in a given jurisdiction, as defined by the International Association of Chiefs of Police Committee on Uniform Crime Reports (UCR). Police departments throughout the United States report on eight crime areas: four categories of Violent Crimes and four categories of Property Crimes.

The Crime Index is the total number of indexed offenses occurring within a given jurisdiction during a specified period of time. In 2023, Bannockburn's crime index was 25.




Calls for service and initiated activity include activity generated by criminal complaints, requests for service, officer-initiated activity, traffic accidents, alarms and a variety of other services provided to our residents and the public. In 2023, the Bannockburn Police Department responded to or initiated 7,037 calls for service. The Bannockburn Police Department will continue to patrol and monitor residential and commercial areas of the Village in an effort to keep our residents and their property safe.



Annual Calls for Service


Fraffic Crashes





In 2011, the Department implemented a Compliance ticket as a way to issue a citation for minor violations. Often times, traffic citations would be dismissed by a judge in court (due to the high fine associated with the charge) or an officer would not issue a ticket. Compliance tickets cover minor infractions such as seat belts violations, equipment violations, etc.

Since our system changed in 2011, officers are able to use this option when stopping a vehicle for a traffic violation in the Village.

Donations and Grants

Department of Justice Ballistic Vest Grant

The Department of Justice reimburses the Department approximately 50% of the funds utilized to outfit officers with ballistic vests.





IDOT Traffic Safety Grant

Traffic Safety Grant money is received to reimburse officer overtime costs related to traffic enforcement. During different times of the year, the focus is on certain violations such as speed enforcement, distracted driving and occupant restraints (seatbelts).

IPRF Grant

Every year the Department receives grant money from the Illinois Public Risk Fund (IPRF). This money is used to purchase equipment mainly related to the TASER program.





Panek Donation

The Panek Family is gracious enough to make a very generous donation each year to the Police Department. Funds are used for special equipment, training or other items to further the mission of the Police Department.

The Deerfield Consolidated Dispatch Center


The Deerfield Consolidated Dispatch Center is located in the Deerfield Police Department. Its members include the Deerfield, Bannockburn, Riverwoods and Lincolnshire Police Departments who all share the same radio frequency and assist each other when needed for emergencies or calls for service. It is an excellent team of agencies working together to serve their communities. The Dispatch Center was remodeled in 2023. improving its capabilities and adding state of the art technology. The Center increased its dispatcher desks from four to five with

the ability to expand to six stations. Additionally, the \$1 million project allows civilians to send text messages to the Center and will soon allow them to send video as well. Here are a couple before and after pictures of the Dispatch Center.





Multi-Jurisdictional Task Forces

In an effort to provide citizens with the best service possible, police departments frequently contribute resources and manpower to regional teams to handle major incidents. This cooperation allows for help, when needed, that would otherwise not be affordable by a single agency. The Bannockburn Police Department belongs to, and participates in, the following task forces:



Major Crash Assistance Team (MCAT)

MCAT was established by an Inter-Governmental Agreement in July, 2004. The Agreement reads in part: "In recognition of the fact that the efficient investigation of serious traffic crashes is enhanced when agencies have access to the resources and support of other agencies. Further, it is recognized that a primary goal in the investigation of serious traffic crashes is to establish an accurate record of the factors and conditions leading up to the traffic crash." There are 29 contributing agencies and 6 non-contributing agencies involved in MCAT. In 2023, Officer Dale Weshinskey responded to serious crash investigations as the Department's representative.


<u>Lake County Major Crime Task Force (LCMCTF)</u>


The Lake County Major Crime Task Force was established in 1992 in response to a mutual need for vast investigative resources and expertise from all Lake County law enforcement agencies. The LCMCTF investigates the county's most serious, often high-profile crimes and incidents such as Murders, non-parental kidnappings, officer-involved shootings, in-custody deaths and heinous crimes where additional resources, specialized training and expertise may be needed. The Lake County Major Crime Task Force is the oldest unit of its kind in the State of Illinois and operates in the third-most-populated county in the state. In its first 31 years of operation, the task force has participated in over 360 major investigations. In 2023, Officer Kiersten Reif represented the Department as an Evidence Technician on the Lake County Major Crime Task Force.



<u>Northern Illinois Police Alarm System (NIPAS)</u> <u>Emergency Services Team (EST</u>

NIPAS was established by an Inter-Governmental Service Agreement in 1983. The specific intent of this agreement is to permit the police departments of each community to more fully safeguard the lives, persons and property of all citizens. The NIPAS Car Plan and Emergency Services Team (EST) is the largest multiagency SWAT Team in the Country. The team consists of more than 100 police officers that can handle any tactical situation or high-risk incident. Officer Jeff Devroy, the Department's EST representative, is a trained NIPAS Negotiator assisting in hostage and barricaded subject calls.





NIPAS Mobile Field Force

The Mobile Field Force is designed to provide rapid, organized and disciplined response to civil disorder and crowd control. Mobile Field Forces are formally structured teams based on a platoon of law enforcement officers from multiple agencies with an assigned leader. Tactics used are based on small squad tactics

developed by the Office of Domestic Preparedness, as well as, the more traditional Mobile Field Force and general police patrol tactics. Officer Frank Czajka has been an active member of the Mobile Field Force since 2019.

The NIPAS Mobile Field Force provides its member agencies with a planned, organized and rapid response to a variety of incidents.





Illinois Law Enforcement Alarm System <u>(ILEAS)</u>

ILEAS was established by an Inter-Governmental Agreement in January of 2003. ILEAS is a product of the Illinois Terrorism Task Force of the Illinois Association of Chiefs of Police and is intended to provide a mutual aid system for all law enforcement agencies operating within Illinois. ILEAS is designed to provide law enforcement assistance to communities during any emergency condition and is not limited to acts of terrorism. ILEAS was modeled after NIPAS, except that ILEAS applies to all Illinois Law Enforcement Agencies (county, state, federal, university and railroad). NIPAS is limited to local municipal law enforcement agencies.

In 2023, Chief Trillhaase was sworn in as the Vice President of Lake County Chiefs of Police Association for the 2024 calendar year.
